

EQUORIENT BETA - PRIVACY POLICY

Last Updated: June 5, 2025.

1. Introduction

The Mindful Spaces Group, LLC ("Company," "we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and disclose information we receive in connection with the EQuorient Beta Program ("Beta Program") and the EQuorient AI tool / EQuorient Operating Sequence (EQOS) (the "Service"). This Privacy Policy applies to Beta Users ("Beta User," "you," or "your") of the EQuorient Beta Program.

2. Information We Collect

We may collect the following types of information:

- **Information You Provide Directly:**
 - **Account Information:** When you register for the Beta Program, we collect information such as your name, email address, and password (hashed).
 - **Beta Feedback:** Information you provide when you give us feedback, suggestions, or bug reports about the Service.
 - **Service Usage Data:** Information about how you use the Service, including your interactions with the AI, the inputs you provide, and the outputs you receive from the AI. **We may collect anonymized usage data to understand feature utilization.**
- **Automatically Collected Information:**
 - **Log Data:** Our servers automatically record information ("Log Data") created by your use of the Service. Log Data may include information such as your IP address, browser type, operating system, the referring web page, pages visited, location, your mobile carrier, device and application IDs, search terms, and cookie information.
 - **Cookies and Similar Technologies:** We may use cookies and similar technologies to collect information and personalize your experience. You can control the use of cookies at the individual browser level, but if you choose to disable cookies, it may limit your use of certain features or functions of the Service.

3. How We Use Your Information

We may use your information for the following purposes:

- **To Provide and Improve the Service:** To operate the Beta Program, provide you with access to the Service, and to improve and personalize the Service based on user feedback and usage patterns.
- **Beta Program Administration:** To manage your Beta Program account, communicate with you about the Beta Program (e.g., updates, surveys), and provide support.

- **Research and Development:** To conduct research and analysis to improve the Service, develop new features, and understand user needs and trends.
- **Customer Support:** To respond to your inquiries and provide customer support.
- **Legal Compliance:** To comply with applicable laws, legal processes, or regulatory requirements.

4. Data Sharing and Disclosure

We may share your information in the following circumstances:

- **With Service Providers:** We may employ third-party companies and individuals to facilitate our Service, to provide the Service on our behalf, to perform Service-related services (e.g., hosting, data analysis, email delivery, customer support), or to assist us in analyzing how our Service is used. These third parties have access to your Personal Information only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.
- **For Legal Reasons:** We may disclose your information if required to do so by law or in response to valid requests by public authorities (e.g., a subpoena or court order).
- **Business Transfers:** In connection with any merger, sale of company assets, financing, or acquisition of all or a portion of our business by another company, or in the unlikely event that we go out of business or enter bankruptcy, user information may be transferred as a business asset.
- **With Your Consent:** We may share your information with your consent, or as otherwise disclosed at the time of data collection or sharing.
- **Aggregated and Anonymized Data:** We may share aggregated or anonymized information that does not directly identify you with third parties for research, marketing, analytics, and other purposes.

5. Data Security

We take reasonable measures to protect your information from unauthorized access, use, or disclosure. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

6. Data Retention

We will retain your Personal Information for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. Beta user accounts and associated data will be retained throughout the beta program and may be deleted or anonymized after the beta program concludes, unless you become a paying subscriber to the full EQuorient service.

7. Your Rights

Depending on your location and applicable privacy laws, you may have certain rights regarding your personal information, such as the right to:

- **Access:** Request access to the personal information we hold about you.
- **Correction:** Request that we correct any inaccurate or incomplete personal information.
- **Deletion:** Request that we delete your personal information under certain circumstances.
- **Objection to Processing:** Object to the processing of your personal information for certain purposes.
- **Restriction of Processing:** Request that we restrict the processing of your personal information under certain circumstances.
- **Data Portability:** Request to receive your personal information in a portable format.

If you are located outside United States and choose to provide information to us, please note that we transfer the data, including Personal Information, to United States and process it there.
